Deviation/ Concession Request

- Supplier Name: Identification of the supplier who is reporting the escape.
- Address: Enter address of the identified supplier.
- Deviation/ Concession No.: Document Identification Number- Unique Number for tracking.
- Supplier Contact: Name of the supplier representative who is reporting the escape.
- Email address and phone number: Email and phone number of the supplier representative.
- Rev.: Level of document revision.
- Page: Page number and total number of pages.
- Part Number: Part number containing the non-conformity.
- Revision: Level of part number.
- Part Description: Part name.
- S/N, Lot or ID number: Part serial number, batch number, lot number, identification number.
- Qty Affected: Quantity of affected parts.
- P.O. affected: Order number where the affected parts will be shipped.
- Non-Conformance description: Text description of the part condition.
- Specified Requirement: Required dimension, characteristic, specification, process, etc.
- Attachment: Yes/ No and # of pages/ files.
- Direct cause: Event(s), action(s) or condition(s) that directly resulted in the detected nonconformity or other undesirable situation that, if eliminated or mitigated, may prevented occurrence.
- Immediate and corrective actions: Actions taken to eliminate/ prevent the cause of the nonconformance.
- Supplier QA Representative: Supplier QA representative submitting the concession/ deviation.
- Supplier Eng representative: Supplier engineering representative submitting the concession/ deviation
- ZAES / ACC Disposition: Explanation of usage/ rework or repair of the components reported.
- ZAES/ACC Eng. Department approval: ZAES/ACC Engineering department providing and approving the disposition.
- ZAES/ACC QA Department approval: ZAES/ACC Quality department acknowledgment and approval of the disposition.
