## Recall of formalities to reduce the processing time of your invoices through our automatic acquisition system.

Your invoices must be submitted in one unfolded copy, without staples and be systematically sent to the mailing address indicated on the order.

**IMPORTANT** - We emphasize the fact that the **order number** and your **supplier tax identification number** (for European suppliers, this is the intra-community VAT no. or fiscal Id) must appear on the invoice in order to avoid further delay (inaccurate or incomplete invoices considerably delay payment).

### Information required by Safran to be displayed on your invoices :

#### Transaction identification elements

- **Order number** (command reference) as shown on the order sent by the Safran company
- Your invoice will be structured as the order with the same order lines details
- **Delivery number** or minutes of receipt number
- Amount, reference and names of **products** or **services** sold
- **Non Quality Event number** related to the **credit note** (according to companies: NQE, inspection report n°,...)

#### Financial information

- At the bottom of your invoice, subtotal + total VAT must be equal to the total
- Settlement date
- Invoice currency
- Any discounts, rate of late penalty
- Advanced payment
- Terms of price escalation

#### Safran company information

- Name of the company of Safran
- Intra-community VAT no (EU VAT number) of Safran company
- Billing address of Safran company
- Invoice mailing address of Safran company including TSA code

#### Your information

- Your bank details : **IBAN code**
- Contact information (name, phone and **email address**) of a person in case of billing dispute
- For French suppliers:
  - Your name, address, RCS, legal form and social capital
  - Your **VAT number**
  - Your **SIREN**
  - Your RCS number along with the city where is the registry of the tribunal of commerce
- For EU area suppliers:
  - Your **VAT number**
- For outside EU suppliers:
  - Your **Fiscal Id or Tax Id**
  - Your **DUNS code** if available

**NB** : if you have signed a convention of fiscal dematerialization (EDI), you must not send paper invoices. In all other cases (including scanning), you must send a paper invoice.

#### To speed up the payment of the invoice

- **one invoice** includes **one single purchase order number**
- as soon as the invoice is issued, send it **without further delay** by mail
- include the **bank details** in the invoice
- a **single bank account** per **currency**
- for French suppliers, specify the tax option « débit » or « encaissement »
- additional documents must be sent directly to the prescriber shown on the purchase order (for example acceptance report)

## **E-MAIL invoice transmission for some SAFRAN COMPANIES with TSA CODE (\*)**

Safran objective is to have EDI invoice transmission with its suppliers. We ask you to contact your buyer to support you in this process. Nevertheless, e-mail invoice transmission is admitted.

As part of a progress plan to improve the process of processing and payment of supplier invoices and reduce the carbon footprint, SAFRAN has created a unique email address to allow its suppliers to address directly their invoices by email.

Advantages of this solution :

- removal of paper
- **traceability** of documents
- **speed** of transmission / **reduction of the deadline** for receipt of invoices

### **To use this solution, it is essential to respect the following three PREREQUISITES :**

- The invoices must be sent in **PDF format** and contain only **one invoice per PDF**.  
SAFRAN declines all responsibility in case of mistreatment if the transmitted PDFs were to contain several invoices.
- The invoices must mention the **TSA code** associated with the invoice mailing address.  
The TSA code is mentioned in 'B' column 'Invoice mailing address with regular mail service' and on the Safran purchase order
