

# GUIDELINES TO USE THE SAFRAN GROUP GPC FOR GERMAN COMPANIES

This document is confidential and must not be disclosed to the Supplier

This document is deemed to be a complement to the Standard and Aeronautical Supplies General Purchasing Conditions of SAFRAN Group Companies located in Germany.

#### For your information:

According to German law, General Purchasing Conditions (GPC) may not be enforceable if not individually negotiated. Therefore, it is essential that the GPC are transmitted to the Supplier for negotiations and to show that those negotiations took place.

It is important to transcribe on the purchase order the negotiated clauses and to have the signature of the Supplier on the Order form in order to avoid any misunderstanding.

#### To do so:

Two options are at your disposal (found below). You must choose one of the two following options when the order is issued on the basis of the GPC:

- Add the mentions and negotiated clauses in the Order form (APPENDIX 1); or
- Sign a side agreement to the GPC (APPENDIX 2): that contains the negotiated clauses and their newest version.

<u>/!!\:</u> Do not accept any Sales Terms and Conditions without negotiations and discussions and propose for negotiations SAFRAN Group's GPC.

Negotiations can be made upwards or downwards as long as it can be proven that negotiations effectively took place!

#### **BETWEEN**

#### WHEREAS:

Whereas, the Purchaser is a SAFRAN Group company specialized, in [...].

Whereas, the Supplier is in charge of the study, development, qualification, supply, industrialization, manufacturing and support<sup>3</sup> of solutions for [Supplier activities].

Whereas, the Parties wish to set forth the terms and conditions under which the Purchaser may purchase the Supply referenced within its Purchase Orders to the Supplier.

Now, therefore, the Parties have decided to negotiate the dispositions of the General Purchasing Conditions/Aeronautical Supplies General Purchasing Conditions<sup>4</sup> (herein after "GPC") signed by the Supplier and referenced in this document (herein after "Agreement").

After discussions and negotiations, the Parties hereby mutually agree to modify the GPC as set forth in this Agreement.

#### IT IS AGREED AS FOLLOWS:

#### **ARTICLE 1**

The purpose of this Agreement is to modify accordingly to the negotiations that took place between the Parties, the GPC as follows.

#### **ARTICLE 2**
