

REQUIREMENTS FOR ALL ORDERS

Note: When the items furnished under this Purchase Order are for use in connection with a U.S. Government prime contractor or subcontract, the following Federal Acquisition Regulations and Defense Federal Acquisition Supplement clauses (collectively, FAR clauses), shall apply as required by the terms of the prime contract or by operation of law or regulation, and are hereby incorporated by reference. The effective version of each FAR provision shall be the same version as that which appears in Buyer's prime contract, or higher-tier subcontract under which this Purchase Order is a subcontract. In all clauses listed herein, the terms "Government," "Contracting Officer," and "Contractor" shall be revised to suitably identify the contracting parties herein and affect the proper intent of the provision. "Subcontractor," however, shall mean "Seller's" "Subcontractor" under this Purchase Order.
