**FEDERAL AVIATION ADMINISTRATION - PARTS MANUFACTURER APPROVAL**

Dear Bill Finch:

In accordance with Title 14, Code of Federal Regulations (14 CFR), part 21, Certification Procedures for Products, Articles, and Parts, subpart K, the Federal Aviation Administration (FAA) has found the design data, as submitted by Safran Cabin Inc. (hereinafter referred to as "the Manufacturer") on November 30, 2018, meets the airworthiness requirements of 14 CFR applicable to the products on which the articles to be installed. Additionally, the FAA has determined the Manufacturer has established the quality system required by § 21.307 at 5701 Bolsa Ave., Huntington Beach, CA 92647 and its associate facilities at: 7330 Lincoln Way, Garden Grove, CA 92841; 1945 Grove Ave., Ontario, CA 91761; 2850 Skyway Dr., Santa Maria, CA 93455; 12730 State Avenue, Marysville, WA 98270; 12810 State Avenue, Marysville, WA 98270; and 11240 Warland Dr., Cypress, CA 90630. Accordingly, Parts Manufacturer Approval (PMA) is hereby granted to the Manufacturer to produce the replacement articles (or modification articles, as applicable) listed in the superseding supplements 1-238 previously issued to C&D Zodiac, Inc. Subsequent changes to the design data must be approved in a manner acceptable to the FAA.

The following terms and conditions apply to this approval:

1. The Manufacturer's quality system, methods, procedures, and manufacturing facilities, including suppliers, are subject to FAA surveillance and investigations. Accordingly, the Manufacturer must advise its suppliers that their facilities are also subject to FAA surveillance and investigations.
2. The Manufacturer must obtain approval from the Los Angeles/Van Nuys MIDO Section prior to relocating or expanding manufacturing facilities from which articles are produced, including the addition of associate facilities. Additionally, this requirement applies to the Manufacturer's suppliers with major inspection authorization, and those suppliers who furnish articles or related services where a determination of safety and conformance to the approved design cannot or will not be made upon receipt at the approved receiving facility.
