2 SCOPE

This Standard applies to all Purchase Orders generated at all Safran Cabin Inc. facilities. If there is any conflict between this document and divisional customer contractual and/or legal requirements the latter will take priority.

5 RESPONSIBILITIES

Quality Assurance

Quality Assurance is responsible for ensuring that all part numbers contain the correct quality clauses and conforms to all customer, FAA, Safran Cabin Inc. Engineering and Safran Cabin Inc. Quality requirements.

It shall be the responsibility of the IMM to inform the designated Quality Assurance personnel of a New Item or product that will require Quality Clauses. Quality Assurance will provide the IMM updates to the quality clauses for updating within the item Master database.

It shall be the responsibility of the designated Quality Assurance personnel to determine if any additional clauses are required. Consideration will be given in regards to the complexity of the product and the control exercised at the supplier facility. Once a quality clause has been applied for a specific part number, additional review of that item is not necessary unless the item undergoes significant engineering changes to form, fit or function.

To ensure compliance and to have the system include the quality clauses on the purchase order, this activity must be performed prior to the requisition submittal to Purchasing. Subsequent purchase orders for that item from that vendor shall include the system generated quality clauses. Quality Assurance will verify compliance to Quality Clauses upon receipt of product.

6 ACTIONS

6.1 Quality Assurance

1. Document new and/or revised Quality Clauses as required.
2. Provide all revised and/or new **Quality Clauses to the IMM for updating in (ERP) Enterprise Resource Planning.**

6.2 Quality Assurance/Control

Verify part number and Quality Clauses at the time of Receiving Inspection.

000 QUALITY CLAUSES NOT REQUIRED

Non shippable items, for Safran Cabin Inc. internal use only.

100 STATISTICAL PROCESS CONTROL

The supplier must apply Statistical Process Control (SPC) to this purchase order. A CPK of 1.33 or greater is required. Each shipment must be accompanied with a signed copy of the applicable SPC Control Plan(s). The Control Characteristic listed in SPC Control Plan shall be approved by Safran Cabin Inc. Quality Assurance prior to commencing with production / processing.

102 FABRICATION INSPECTION SYSTEM (FIS) FAR21.303

The supplier's, shall maintain a FIS in compliance with the requirements of FAR 21.303 (h). The FIS shall be approved and subject to audit by FAA, or its representative at any time.

103 QUALITY SYSTEM SURVEILLANCE

As a Safran Cabin Inc. supplier manufacturing a product requiring Safran Cabin Inc. Customer and/or "Federal Aviation Administration" (FAA) approval, the Seller's "Quality Control System" shall be subject to surveillance by Safran Cabin Inc. and the FAA.

104 FAA-PMA /TSOA

As a Safran Cabin Inc. supplier manufacturing an article or component for which Safran Cabin Inc. holds an FAA Parts Manufactures Approval (PMA) or Technical Standard Order Authorization (TSOA), your inspection system shall be subject to inspection by Safran Cabin Inc. and /or FAA at a level commensurate with criticalness of the article or component.

105 RIGHT OF ENTRY

Allows Safran Cabin Inc., its customers and regulatory agencies the right of access, through prior notification, to determine and verify the quality of work, applicable quality records and materials at all applicable area of all facilities, at any level of the supply chain, involved in the order.

106 GOVERNMENT SOURCE INSPECTION (GSI)

Government inspection is required prior to shipment from your plant. Evidence of such inspection must be indicated on the packing sheet accompanying each shipment. On receipt of this Purchase Order, promptly contact the Government Representative who normally services your plant, or if not available, or the representative or office cannot be located, Safran Cabin Inc.'s buyer should be notified. Drawing(s), test document(s) and specifications, as applicable, covering material on this order shall be available for inspection at your plant.

107 REQUIREMENT FOR AIRWORTHINESS CERTIFICATION

FAA/Foreign Civil Airworthiness Authority (FCAA) Conformity Certification is required for articles specified on this purchase document. Include with each shipment, a true copy of FAA Form 8130-3, Release Certificate Approval Tag, for Airworthiness. Foreign government equivalent to FAA Form 8130-3 is acceptable for imported articles.

108 AS9102 FIRST ARTICLE INSPECTION (FAI) BY SELLER

An FAI per AS9102 shall be performed on all new or revised manufactured items by the seller or at the seller's facility using only AS9102 forms *or* CDS1005 forms. *All FAIR's shall be entered in to Net-Inspect and submitted upon a notification/memo from the SAFRAN Business Unit.* Complete reports shall be submitted to Safran Cabin Inc. for all product-specific first-time shipments and delta FAIs (at a minimum) for any manufacturing changes thereafter *as per AS9102 guidelines or as per Safran Cabin Inc. Purchase Order requirements. Any/all deviations to the requirement shall be approved by a Safran Cabin Inc. Supplier Quality representative prior to submitting the FAIR and shipping the parts. FAIR shall be submitted prior to shipping the parts.*

110 FIRST ARTICLE INSPECTION (FAI) BY SAFRAN CABIN INC. AT SELLER'S FACILITY

FAI and/or test shall be accomplished at the Seller's facility before the balance of order may be shipped. Safran Cabin Inc. will **conduct** or witness inspections and/or tests and the results will be on a report form identified as "First Article Inspection Report".

111 SAFRAN CABIN INC. SOURCE INSPECTION

Safran Cabin Inc. inspection is required prior to shipment from your facility. Evidence of such inspection must be included in your packing documents accompanying each shipment. You must contact Safran Cabin Inc.'s buyer and establish verification arrangements and the method of product release. Drawings, inspection/test documents, and specifications, as applicable, covering material on this order shall be available for inspection at your facility.

112 DELEGATION - SUPPLIER VERIFICATION OF SAFRAN CABIN INC. PRODUCT

The supplier has met the requirements established by Safran Cabin Inc. quality organization for the verification of Safran Cabin Inc. product.

* Note: Clause applicable to R4 ERP system only. M3 suppliers will be identified using C2D PO type.

114 CHEMICAL AND PHYSICAL TEST REPORTS

Each shipment must be accompanied by one (1) legible and reproducible copy of all chemical and physical test reports identifiable with materials ordered. The reports must contain the signature and title of the authorized representative of the agency performing the test and must assure conformance to specification requirements.

116 SHELF LIFE CONTROLLED MATERIAL; 80% SHELF LIFE REQUIRED AT RECEIPT

Time sensitive material shall be furnished with a minimum of 80% of its *remaining shelf life when the part is delivered to the Buyer's facility. Shelf life duration shall be calculated against the manufacturer's date of manufacturing and date of expiration.* Shelf life duration, date of manufacturing and date of expiration shall be listed on the material certification.

1161 SHELF LIFE CONTROLLED MATERIAL; 75% SHELF LIFE REQUIRED AT RECEIPT

Time sensitive material shall be furnished with a minimum of 75% of its *remaining shelf life when the part is delivered to the Buyer's facility. Shelf life duration shall be calculated against the manufacturer's date of manufacturing and date of expiration.* Shelf life duration, date of manufacturing and date of expiration shall be listed on the material certification.

1162 SHELF LIFE CONTROLLED MATERIAL; 70% SHELF LIFE REQUIRED AT RECEIPT

Time sensitive material shall be furnished with a minimum of 70% of its *remaining shelf life when the part is delivered to the Buyer's facility. Shelf life duration shall be calculated against the manufacturer's date of manufacturing and date of expiration.* Shelf life duration, date of manufacturing and date of expiration shall be listed on the material certification.

1163 SHELF LIFE CONTROLLED MATERIAL; 65% SHELF LIFE REQUIRED AT RECEIPT

Time sensitive material shall be furnished with a minimum of 65% of its *remaining shelf life when the part is delivered to the Buyer's facility. Shelf life duration shall be calculated against the manufacturer's date of manufacturing and date of expiration.* Shelf life duration, date of manufacturing and date of expiration shall be listed on the material certification.

1164 SHELF LIFE CONTROLLED MATERIAL; 50% SHELF LIFE REQUIRED AT RECEIPT

Time sensitive material shall be furnished with a minimum of 50% of its *remaining shelf life when the part is delivered to the Buyer's facility. Shelf life duration shall be calculated against the manufacturer's date of manufacturing and date of expiration.* Shelf life duration, date of manufacturing and date of expiration shall be listed on the material certification.

1165 SHELF LIFE CONTROLLED MATERIAL; 40% SHELF LIFE REQUIRED AT RECEIPT

Time sensitive material shall be furnished with a minimum of 40% of its remaining shelf life when the part is delivered to the Buyer's facility. Shelf life duration shall be calculated against the manufacturer's date of manufacturing and date of expiration. Shelf life duration, date of manufacturing and date of expiration shall be listed on the material certification.

1166 SHELF LIFE CONTROLLED MATERIAL; 60% SHELF LIFE REQUIRED AT RECEIPT

Time sensitive material shall be furnished with a minimum of 60% of its *remaining shelf life when the part is delivered to the Buyer's facility. Shelf life duration shall be calculated against the manufacturer's date of manufacturing and date of expiration.* Shelf life duration, date of manufacturing and date of expiration shall be listed on the material certification.

1167 SHELF LIFE CONTROLLED MATERIAL; 33% SHELF LIFE REQUIRED AT RECEIPT

Time sensitive material shall be furnished with a minimum of 33% of its *remaining shelf life when the part is delivered to the Buyer's facility. Shelf life duration shall be calculated against the manufacturer's date of manufacturing and date of expiration.* Shelf life duration, date of manufacturing and date of expiration shall be listed on the material certification

1168 SHELF LIFE CONTROLLED MATERIAL; 90% SHELF LIFE REQUIRED AT RECEIPT

Time sensitive material shall be furnished with a minimum of 90% of its remaining shelf life when the part is delivered to the Buyer's facility. Shelf life duration shall be calculated against the manufacturer's date of manufacturing and date of expiration. Shelf life duration, date of manufacturing and date of expiration shall be listed on the material certification.

1169 EMERGENCY EQUIPMENT USED ON EMB PROGRAMS AND SHELF LIFE CONTROLLED MATERIAL SOLD TO EMB

Emergency Equipment purchased to be used on EMB programs and shelf life material purchased to be sold to EMB shall be furnished with a minimum of 90% of its shelf life remaining at date of receipt. Shelf life duration, date of manufacture and date of expiration shall be listed on material certification.

117 RAW MATERIAL IDENTIFICATION (AS APPLICABLE)**A. Sheet or Plate Stock - Metallic or Non-Metallic**

Each sheet or plate shipped shall be identified by continuous stenciling, of sufficient size to be readily legible, applied by permanent ink or dye of contrasting color, non-injurious to metal surfaces and not soluble.

B. Rod, Bar or Tube - all shapes - 1/2 inch cross section or larger

Each length of Rod, Bar or Tube shipped shall be identified at one end or by continuous stenciling, of sufficient size to be readily legible, applied by permanent ink or dye of contrasting color, non-injurious to metal surfaces and not soluble in cutting and coolant oils. If continuous, spacing between groups of stencil letters shall not exceed twelve (12) inches. Information shall include material type or designation, material specification and temper.

C. Rod, Bar or Tube - all shapes - Smaller than 1/2 inch cross section

Rod, bar or tube shipped shall be bundled together; each bundle containing materials from the same (manufacturing/heat treatment) batch, and shall be identified as follows: An adhesive label or identification tag shall be securely attached to each bundle. This label or tag shall be permanently marked to indicate material type or designation, material specification and temper.

D. Castings / Forging - Ferrous or Non-Ferrous

Material shipped shall be identified with the part number, "melt" number, heat treat lot (if applicable) and serial number (if applicable). Identification of parts shall be in accordance with applicable drawings/specifications. Where drawings or specifications do not define method of identification, such identification shall be effected in accordance with MIL-STD-130.

E. Extrusions

Each length of extrusion shall be identified at one end or by continuous stenciling, of sufficient size to be readily legible, applied by permanent ink or dye of contrasting color, non-injurious to metal surfaces and not soluble in cutting and coolant oils. If continuous, spacing between groups of stencil

letters shall not exceed twelve inches. Information shall include material type or designation, material specification, temper and heat lot number.

118 ELECTRICAL EQUIPMENT

Each shipment shall be accompanied by one (1) legible and reproducible copy of a certificate containing the signature and title of the person authorizing the release of product. The certificate shall contain the part number, specification to which they conform, and general characteristic. When the parts are serialized, serial numbers shall be included on the certification. Manufacturer will maintain test reports, specification conformation and general characteristics on-site and available upon request.

119 ELECTRICAL CABLES (WIRES)

Electrical cables shall be identified with the part number and manufacturing code. The spool, and Certificate of Conformance shall be identified per applicable standard/specification with the following information: standard / specification, size code, manufacturing year, country code (if applicable), and manufacturer.

121 NON-DESTRUCTIVE TEST/INSPECTION IDENTIFICATION

All parts found to be acceptable by non-destructive testing methods are to be so identified by placing the proper acceptance test /inspection stamp on such acceptable parts. All parts found to be unacceptable are to be so identified by placing the proper withholding stamp on such defective parts.
